- 1. In preparation for the 2024 Northern Mindanao Regional Athletic Association (NMRAA) Meet on May 13-17, 2024 at Camiguin Province, the field is hereby informed on the conduct of school-based training of athletes effective May 2, 2024 to May 8, 2024.
- 2. The training aims to:
 - a. enhance the competence of athletes in their respective disciplines;
 - b. raise the over-all performance in the 2023 NMRAA meet; and
 - c. establish teamwork among members of the team and the entire delegation.
- 3. The venues of the said school-based training are the winning schools of the different events. To expedite the conduct of the training, coaches, assistant coaches, chaperons, trainers and athletes are excused from joining their respective classes. It is highly advised that school shall provide assistance and other needs of the athletes during the conduct of the training.
- 4. On the same basis, assistance should be given to learners who are representing their schools during sports competitions. Teachers or any other school personnel/officials threatening their learners by indiscriminately deducting or refusing to give them grades/ratings while at the same time allowing them to participate in sports competitions shall be held responsible.

Teacher-coaches, assistant coaches, chaperons & trainers shall be entitled to service credits in accordance with DepEd Order 53, s. 2003: *Updated Guidelines on the Grants of Vacation Service Credit to Teachers*. On the other hand, non-teaching personnel including the management staff shall be provided with Compensatory Time Off (CTO) as per Civil Service Commission (CSC) and Department of Budget and Management (DBM) Joint Circular No. 2, s. 2004 on Non-Monetary Renumeration for Overtime Service Rendered.
